Whereas, section 103(5) of the General Municipal Law permits the Board to standardize on particular types of kinds of equipment, material, supplies or services for reasons of efficiency or economy; and

Whereas, the District currently uses Mercedes fire hose on its apparatus; and

Whereas, the District needs to order replacement fire hose; and

Whereas, it is imperative that the fire hose used on the District's emergency apparatus be completely compatible and interoperable; and

Whereas, all apparatus must be equipped with the same fire hose; and

Whereas, it is not operationally prudent or efficient to have different fire hose systems installed on District apparatus; and

Whereas, the Board hereby declares that the foregoing reasons of safety, economy, efficiency, and continuity of service demonstrate a need for standardization on Mercedes fire hose; and
